Guidelines for Participation

- A single page word file with synopsis of the project (Max 300 words in A4 sheet, if possible with some relevant pictures) to be sent (emailed) on or before 5.00 pm on 15th December 2022.
- The synopsis should contain the following:
 - a Project title
 - **b** Whether it is a Six Sigma or Task Achievement
 - Background of the project
 - d Linkage with the business
 - Root causes identified
 - f Process improvements carried out
 - g Results/Benefits

Guidelines for Evaluation

Panel of eminent judges will be evaluating the projects on the basis of DMAIC/Task achieving QC Story approach. Presentation time for each team will be 20 minutes plus 5 minutes for Questions & Answers.

Participants per Team:

A Maximum of only 3 members will be allowed per team. Only registered team and participants are eligible to participate.

However, as a contingency plan, change in nomination of any one member may be allowed by the NIQR Management with prior permission by 5.00 pm on 20th December 2022.

Team consisting of more than 3 persons will have to pay Additional fees of Rs.4,000/- + 18% GST (Rs.4,720/-) per participant for each additional team member.
